1. Supervision & Environment

All sessions take place at the home of the host family listed above, with a hosting adult present throughout. In line with standard youth-work transparency practices, the door to the activity room will remain open or ajar at all times — ensuring the game remains accessible, unisolated, and completely open to parental oversight.

2. Safeguarding & Programme Standards

This activity is a private youth programme operated independently by Fable Forge. It is not affiliated with any third-party organisation. The facilitator brings a formal background in youth work and applies a robust safeguarding framework to all sessions, including:

- Full transparency at all times — no isolated one-on-one contact between the facilitator and any minor.
- Treating all participants with respect, fairness, and care.
- Immediately reporting any welfare concerns to parents or guardians.

3. Communication Policy

To maintain clear professional and safety boundaries, the following communication policy applies:

- **Zero Direct Contact:** The facilitator will have no direct online contact, private messaging, or social media interaction with youth participants.
- **Parental Liaison:** All scheduling, logistics, and timing will be coordinated through the host parent and/or a parents' group communication channel.
- **Session Materials:** Written session recaps and lore updates will be distributed exclusively through the parent liaison.
- **Open Access:** Parents are welcome and encouraged to contact Ruairí directly at any time via the details above.

4. Gameplay Themes & Content

Dungeons & Dragons is a collaborative, imagination-based game that encourages critical thinking, problem-solving, and dramatic storytelling. The following content boundaries apply to all sessions:

- **Tone & Content:** Sessions are run at a 12A level of fantasy adventure — comparable to The Avengers or The Lord of the Rings. Real-world adult themes including alcohol, substance abuse, and graphic violence are strictly off-limits.
- **Cooperative Play:** D&D is a team game. Players are expected to cooperate, solve problems together, and support one another's characters. Actions that deliberately harm or steal from other player characters are not permitted.
- **Character Alignment:** Players are not permitted to play evil characters. Characters must act as heroes, mercenaries with a conscience, or protectors of the community.
